# **Essential Water**

Water and Sewer Price List



Under Section 310 of the Water Management Act 2000 and Regulations, Essential Energy is required to set the maximum scale of charges to apply for the 12 months commencing on 1 July 2025 (in accordance with the IPART Determination and Final Report dated December 2022).

# **ACCOUNTS**

Accounts are calculated on the actual number of days between meter readings and the total consumption (kL) registered on the meter during that period. Accounts will be rendered at regular intervals determined by Essential Energy.

# **EXPLANATORY NOTES**

The following criteria are used to determine which prices apply to water customers:

**Residential Tariff:** Applicable to water consumed in premises wholly or principally used as private residences or flats.

**Non Residential Tariff:** Applicable to water consumed in premises wholly or principally used as a place of business.

**Exempt Tariff:** As per the Water Management Act 2000 exempt tariff applies to the following properties:

- I. Land owned by the Crown, being:
  - a. State school land, and
  - b. Land used or occupied as a playground in connection with such school, or as the residence of a caretaker, servant or teacher of any such school;
- II. Land which belongs to and which is occupied and used in connection with any school registered under the Bursary Endowment Act 1912, or any certified school under the Public Instruction (Amendment) Act 1916, including any playground which belongs to and is used in connection with any such school, and any building occupied as a residence by any caretaker, servant or teacher of any such school which belongs to and is used in connection with the school;
- III. Land which belongs to a religious body and which is occupied and used in connection with any church or other building used or occupied for public worship.

**Treated Water Tariff:** Water that has been filtered and / or disinfected.

Untreated Water Tariff: Surface water or ground water that has not been treated in any way.

**Chlorinated Water Tariff:** Surface water or ground water that has been treated with chlorine (Including Sodium Hypochlorite but not limited to)

**Effluent Water:** Water that has been treated at a sewage treatment works.

# Water Usage

Essential Water has no longer continued its quarterly two tier tariff pricing structure for household and non-residential customers. A one tier tariff pricing structure is now in used.

# **Water Availability**

Water Availability charges are published as annual charges and are levied as a daily rate multiplied by the actual number of days between meter readings.

# **Residential Sewer Availability**

Sewer Availability charges are published as annual charges and are levied as a daily rate multiplied by the actual number of days between meter readings.

All residential premises are charged \$652.33 per customer service connection per year regardless of nominal size of water service.

# **Non-Residential Sewerage Charges**

Non-residential customers are charged two different types of sewerage charges according to the New South Wales Government Best Practice Water and Sewerage Guidelines:

1. Availability charge: proportional to the water meter size, charged cents per day.

2. Sewer usage charge: rated on the amount of water usage (kL) through your water meter (\$1.60/kL).

A Sewer Discharge Factor (SDF) is applied to both your availability charge and sewer usage charge. The Sewer Discharge Factor (SDF) is a number between 0.15 and 0.95 increasing in 0.05 increments and is dependent on your business type.

The SDF is typically the ratio of the estimated volume discharged into the sewer system compared to the total water consumed by the customer– reflecting the impact of their water use on the sewerage system.

The New South Government Best Practice Water and Sewerage Guidelines provide a list of recommended sewer discharge factors for different business types.

The customer's account will show the entire sewer availability and sewer usage charge. In the line under each of these separate charges there is a credit for the difference between the entire charge and the sewer discharge factor.

For example a small retail shop with a SDF of 0.95 will be separately credited five per cent of the charges – this means the business only pays 95 per cent of each charge.

#### UNMETERED PROPERTY

All properties to be levied \$409.39 per property plus a deemed consumption of 300kL per annum.

#### UNCONNECTED PROPERTY

All properties with no capital improvements not connected to the water supply system will have no charges.

# **FLATS AND UNITS CHARGES**

In line with NSW Government Best Practice Pricing Principles and in accordance with Best Practice Guidelines each flat/unit is treated as a residence in its own right. This means that each flat/unit receives Water Usage Charges per quarter at tier 1 as per the treated water residential charges. Additionally, each flat/unit is charged a water availability and sewer availability. For example, a premise with three flats will be charged as follows:

# **OBSOLETE TARIFFS**

From time to time water pricing options are made obsolete. Water customers will remain on obsolete prices until such time that the water customer sells the premise. The tariffs listed as obsolete are not available to water customers moving into premises or purchasing a property.

# **CUSTOMER PENSIONER WATER AND SEWER REBATE**

Flat Water and Sewer rebate or Water rebate only is available for eligible pensioners and delivered by Essential Energy through rebates on water service accounts.

Eligible pensioners are defined as those person(s) whose name(s) appear on the water account for supply to his/her/their principal place of abode and hold:

- > Centrelink Pensioner Concession Card: or
- > Department of Veterans Affairs Pensioner Concession Card; or
- > Department of Veterans Affairs Disability Pension at the 'totally and permanently incapacitated' (TPI) rate only.

Applicants must own and be living at the property.

The rebate is calculated on a daily rate basis and applied based on the number of days in each billing cycle.

# TRADE WASTE CHARGES

Liquid Trade Waste is defined as liquid trade or factory wastes or chemical or other impurities from any business, trade or manufacturing premises other than domestic sewage from a hand wash basin, shower, bath, and toilet. It also excludes storm water and unpolluted water:

- > Liquid Trade Waste discharges to the sewerage system include liquid wastes discharged from:
- > Business/commercial premises (eg beautician, florist, hairdresser, hotel, motel, restaurant, butcher, service station, supermarket and dentist);
- > Community/ public premises (including craft club, school, college, university, hospital and nursing home);
- > Industrial premise;
- > Trade activities (eg mobile carpet cleaner); and
- > Any commercial activities carried out at a residential premise.
